There will be a quick meeting of the Board of Directors or the purpose of:

1. Approving the financial review for the 2014-2016 term.
2. Change Standing Rules:
Add to 19.06 Investment Accounts
 - c. Guggenheim Life and Annuity
 1. In December of 2012, a \$50,000 investment fund was established from the sale of 1228 Cherokee Road property in Louisville, KY.
 2. These funds shall be held in perpetuity and can only be used by a vote of the Board of Directors for and emergency related to the headquarters building, contents and/or property .
 - a. Interest earned annually will be placed into the GFWC Kentucky General Fund.

This Standing Rule was passed at the 2014 Convention and never added to the Standing Rules.

 - b. Headquarters Operation
 2. 1228 Society - eliminate
104 Society - replace
 - a. 12.28 - eliminate
10.40 - replace
 - b. 122.80 - eliminate
104.00 - replace
 - c. 1228.00 - eliminate
1040.00 - replace
 3. Rent - strike section

The 104 Society was approved under the Fundraising report on Sunday, May 22, 2016 Board of Directors Meeting.

A quorum of 35 must be present for the meeting to take place. Announcement of this meeting was announced on at the Board of Directors meeting on Sunday May 22, 2016.
